

# The OIG Releases New Medicaid Provider Video



Whether you're new to Medicaid or want to brush up on your knowledge, the Texas Health and Human Services Office of Inspector General (OIG) offers educational resources to help providers ensure that they comply with program rules and regulations. pediatric dental clinic in Odessa for \$22,297. As part of this goal, the OIG has released an informational video that focuses on new Medicaid providers. The video also serves as an important reminder for current providers to double-check their current processes to confirm they follow necessary requirements.

The video highlights the rules and regulations all Medicaid providers must follow. It also discusses provider responsibilities including:

- Staying informed on Medicaid policies.
- Maintaining accurate records.
- Ensuring proper coding and billing.
- Preventing overpayments.
- Not hiring excluded individuals.
- Handling overpayments through self-disclosure.

Failure to comply with these responsibilities, whether accidental or intentional, could result in costly mistakes.

For example, in the first quarter of fiscal year 2025, the OIG entered into a settlement agreement with a

reimbursed the provider for resinbased composites, stainless steel crowns and therapeutic pulpotomies. However, the provider did not have records or x-rays to support the services billed. The documentation that was provided failed to show the services were medically necessary and rendered in accordance with dental standards of care.





More than 4,000 dental professionals attended the 2025 TDA Meeting on May 8-10 at the Henry B. Gonzalez Convention Center in San Antonio.



## Texas A&M University College of Dentistry Professor Honored with Teaching Award

Dr Shaun M. Logan, a professor in Texas A&M University College of Dentistry's biomedical sciences department in Dallas, is one of 10 recipients of the 2024-25 Texas A&M System's Provost Academic Professional Track Faculty Teaching Excellence Award.

The award, presented annually by The Office of the Provost and the Center for Teaching Excellence, highlights the impact of effective teaching and the importance of student-centered learning. Logan and other recipients each received a \$5,000 stipend for teaching projects and support initiatives. She will use the money to support her teaching approach and for professional development, which includes Logan's longstanding attendance at the Texas A&M University Transformational Teaching and Learning Conference.

Logan is dedicated to designing engaging and meaningful learning experiences for students.

"My goal is to foster a dynamic, student-centered classroom where learners are not just absorbing information but actively engaging in the learning process, building connections and developing critical-thinking skills," she said.

Dr Lynne A. Opperman, a recently retired professor of biomedical sciences, nominated Logan and praised her empathy and rapport with students.

"Her fairness makes her invaluable as a constant beacon for the students to use to calibrate themselves as they move through the challenges of the dental education program," Opperman said. "Even with her large load of teaching responsibilities, Shaun has managed to sustain a productive research program."

Logan joined the dental college in 2010 as a postdoctoral research associate and became an assistant professor in 2017. She earned a bachelor's degree in biology from Xavier University of Louisiana, a master's degree in biology from Jackson State University and a doctorate in pharmacology and neuroscience from the University of North Texas Health Science Center in Fort Worth.

"We take great pride in her achievements, and she is truly worthy of the award," said Dr. John K. Neubert, biomedical sciences' new department head.

You may refuse to contribute without reprisal, and the Texas Dental Association and its local component societies will neither favor nor disadvantage anyone based on the amount or failure to make contributions. According to Texas state law, political action committees may only accept contributions from individuals, professional corporations, and professional associations. State law requires political action committees to request and make best efforts to report the name, mailing address, occupation, and employer for each individual whose contributions aggregate in excess of \$100 in a calendar year.
